## Secretary of Agriculture Declaration Deadline Approaching in New Jersey for SBA Working Capital Loans

**ATLANTA** - The U.S. Small Business Administration is reminding small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private non-profit organizations of all sizes that **Oct. 15** is the filing deadline for federal economic injury disaster loans in **New Jersey** as a result of the drought, high winds, hail, excessive heat, excessive rain, flooding, Hurricane Sandy, a snowstorm and a Nor'easter between June 28 and Nov. 8, 2012.

The loans are available in the following counties: Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Mercer, Monmouth, Morris, Ocean, Passaic, Salem, Sussex and Warren.

Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers, or ranchers. Nurseries are eligible to apply for economic injury disaster loans for losses caused by drought conditions.

The loans are for working capital and can be up to \$2 million with interest rates of 4 percent for eligible small businesses and 3 percent for non-profit organizations, and terms up to 30 years.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at <a href="https://disasterloan.sba.gov/ela">https://disasterloan.sba.gov/ela</a>.

Completed loan applications must be returned to SBA no later than October 15, 2013.
