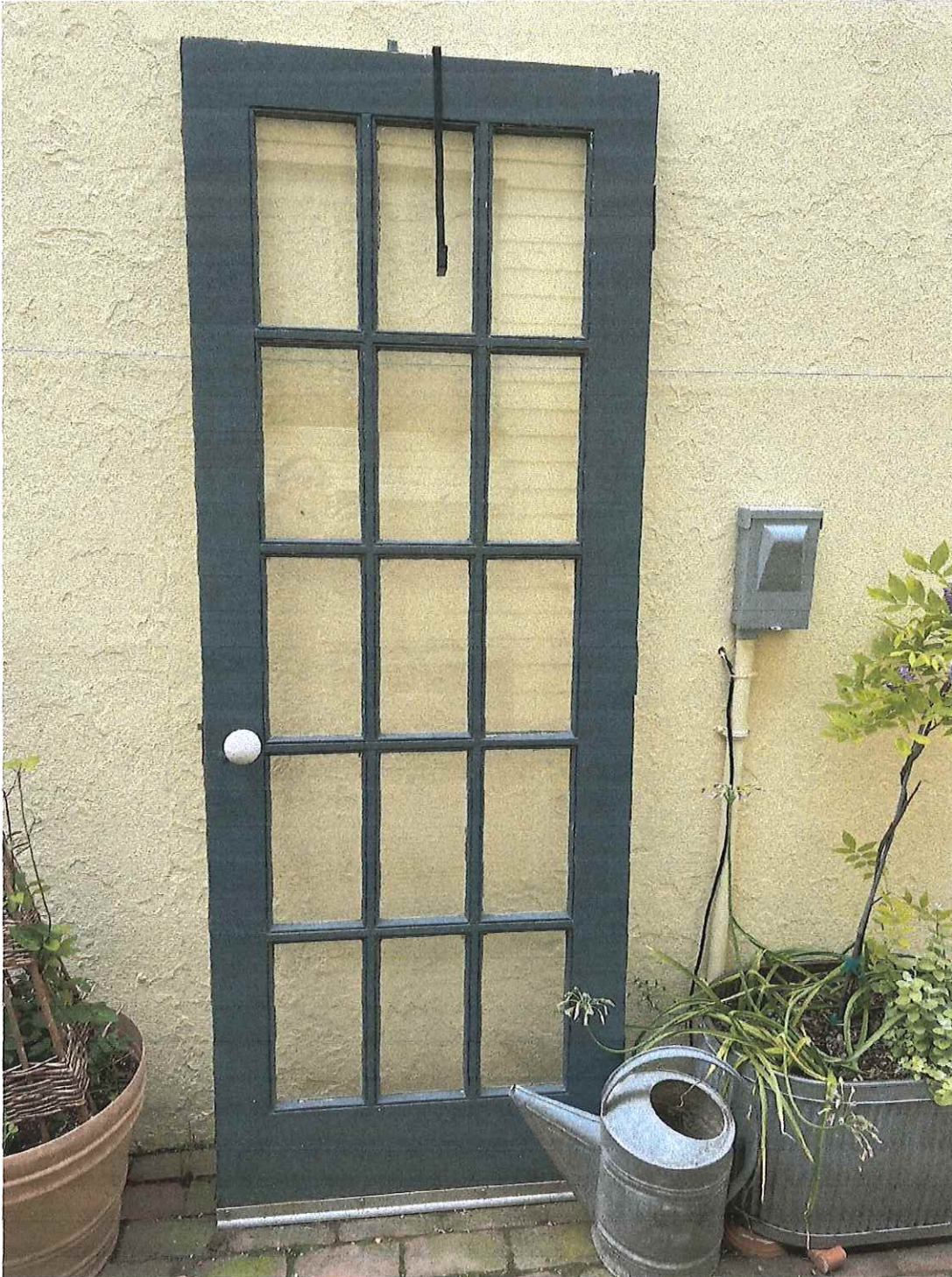

Propose using the original door from the renovation in 2015 which was found in the backyard See image below). The second door will be sourced to be identical to the original door to make up the proposed French doors.

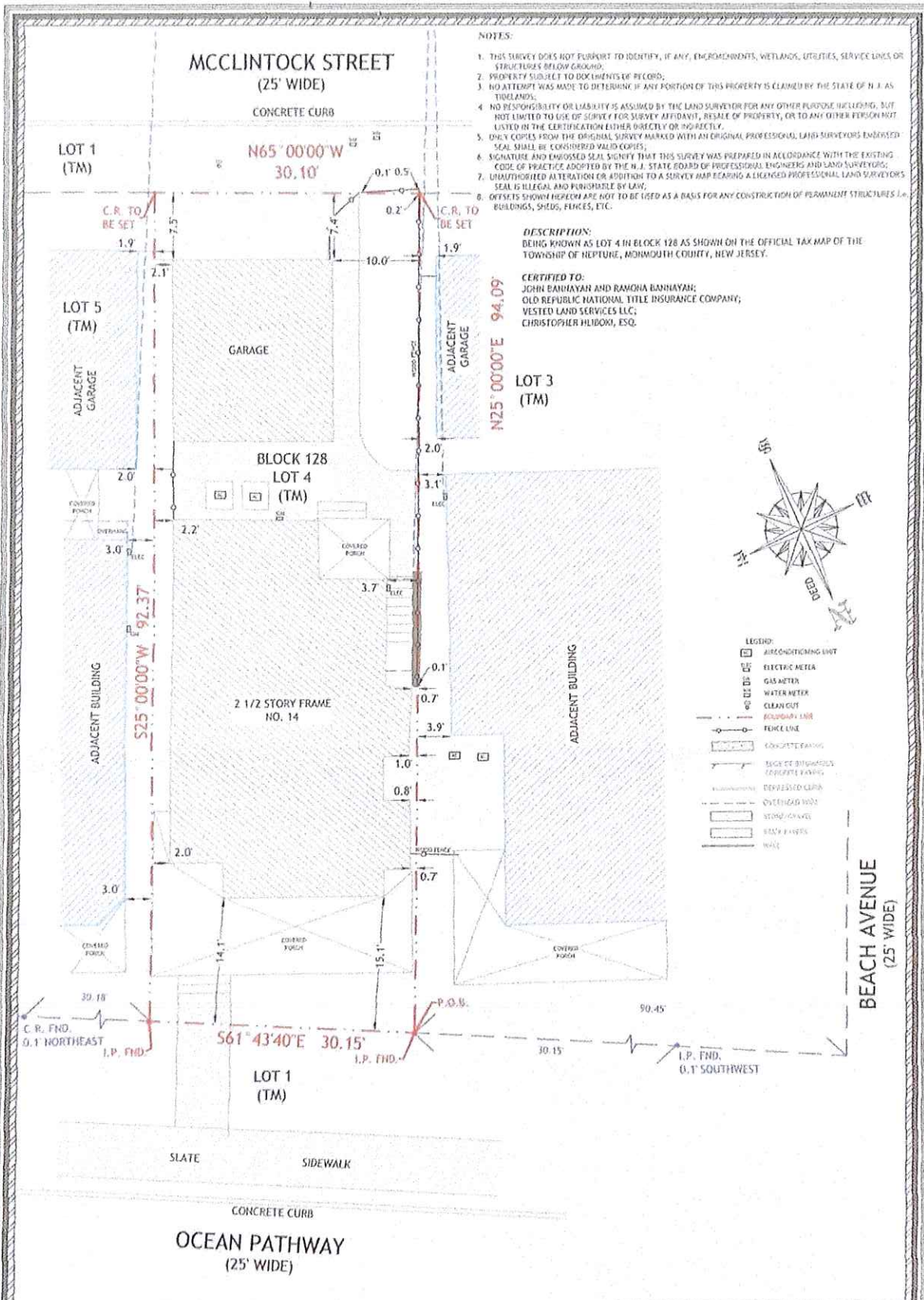




Existing garage door

Current view of the home showing the door styles.



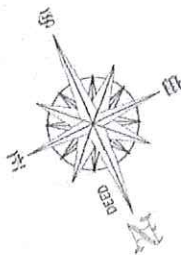
