NOTICE OF FINAL ADOPTION OF BOND ORDINANCE NO. 17-36 AND SUMMARY**

The bond ordinance, the summary terms of which are included herein, has been finally adopted by the Township Committee of the Township of Neptune, in the County of Monmouth, State of New Jersey on August 28, 2017 and the twenty (20) day period of limitation within which a suit, action or proceeding questioning the validity of such ordinance can be commenced, as provided in the Local Bond Law, has begun to run from the date of the first publication of this statement. Copies of the full ordinance are available at no cost and during regular business hours, at the Clerk's office for members of the general public who request the same. The summary of the terms of such bond ordinance follows:

**Title:** BOND ORDINANCE PROVIDING FOR ACQUISITION OF GREEN ACRES PROPERTY LOCATED ON SOUTH RIVERSIDE DRIVE, BY AND IN THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$1,280,000 THEREFOR (INCLUDING \$960,000 NJDEP GREEN ACRES AND \$40,000 MONMOUTH CONSERVATION FUND GRANTS) AND AUTHORIZING THE ISSUANCE OF \$192,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

**Purpose(s):** Acquisition of Green Acres property located on South Riverside Drive (Block 5305, Lot 1 on the Official Township Tax Map)

**Appropriation:** \$1,280,000

**Bonds/Notes Authorized:** \$192,000

**Grant:** \$960,000 NJDEP Green Acres Grant and \$127,500 Monmouth Conservation Fund Grant

**Section 20 Costs:** \$25,000

**Useful Life:** 40 years

ORDINANCE NO. 17-38

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII, SECTION 7.7-4 OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY DESIGNATING A NO STOPPING OR STANDING ZONE DURING CERTAIN HOURS ON A PORTION OF ELY ROAD

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-7.4, Stopping or Standing Prohibited During Certain Hours on Certain Streets - is hereby amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Hours</u>	<u>Location</u>
Ely Road	South	7:00 a.m. to 3:00 p.m. Monday to Friday	Between the intersection with Carton Avenue and the Intersection with Brighton Avenue.

SECTION 2. This ordinance shall take effect upon publication in accordance with law.
